**Parking:** Valet parking only at \$26/day

**Basic Guidelines(\*):** If the distance from your office to the meeting site is under 35 miles, ASMFC will not reimburse hotel, mileage or per diem but may reimburse any miscellaneous expenses that would not normally occur during a work day (i.e., parking, tolls). You are responsible for determining your arrival and departure times. ASMFC reserves the right to disallow travel expenses it deems excessive or unnecessary to conduct ASMFC business.
