The Business Meeting of the Atlantic States Marine Fisheries Commission convened in the Presidential Ballroom of the Crowne Plaza Hotel Old Town, Alexandria, Virginia, August 15, 2007, and was called to order at 4:45 o'clock p.m. by Chairman George D. LaPointe.

#### **CALL TO ORDER**

CHAIRMAN GEORGE D. LAPOINTE: We will move to a business meeting, and we have one agenda topic. We have got a number of agenda topics, but they will all be pretty easy.

# REVIEW OF NON-COMPLIANCE RECOMMENDATIONS

MR. ROBERT H. BOYLES, JR.: Thank you, Mr. Chairman. The ISFMP Policy Board today approved a motion, and so I would like to make it on behalf of the Interstate Fishery Management Program Policy Board: I move that the full commission find the state of Maine out of compliance effective September 24<sup>th</sup>, 2007, for not fully and effectively implementing and enforcing Amendment 2 and Technical Addendum I to the Interstate Fishery Management Plan for Atlantic Herring.

The state of Maine has not implemented the spawning restrictions (Section 4.3.2) contained in the plan. The spawning restrictions are necessary to protect the spawning aggregations that are highly susceptible to fishing in order to ensure continued recruitment to the stock. In order to come back into compliance, the state of Maine must implement the spawning restrictions as detailed in Amendment 2 and Technical Addendum I.

We have a motion from the ISFMP Policy Board. Any discussion? All those in favor of the motion, raise your hand; all opposed; null; abstentions. The motion carries 13 for; zero against; zero nulls; two abstentions.
